Advantage to completing the Nebraska Level I online at www.PASRR.com.

- *Increased efficiency* by providing the ability to submit all information at one time **including** the questions historically asked by Ascend reviewers when certain presenting information is present.
- *Increased accessibility* by offering the capacity to submit and search submitted information 24-hours per day, 7 days per week, 365 days per year.
- *Immediate information access and improved communication between referring agencies and admitting nursing homes* through the ability to electronically print the completed web-based form. The web-based system will allow the person entering the information to print both the screening information and the outcome.
- *HIPAA Compliance* through the web-based system which allows *submission* of information and status of PASRR review ONLY on a PASRR request you have entered. Our web-based data is HIPAA compliant and integrates access control, authentication, and a 128-bit encryption key signed by Verisign to guarantee the security of network connections, the authenticity of local and remote users, and the privacy and integrity of data communications. As a contractor of the State of Nebraska, Ascend maintains fully compliant HIPAA practices with all communications about personally identifiable client information.
- *'User Friendly' access* with no IS/IT modifications or programming needs from providers to access information or submit screens. With web-based access, the provider simply accesses a specified internet address and enters their user name and password to begin entering information. The only changes necessary on the part of the provider may be to change settings on individual computers to print the completed screening information. Any special printing instructions will be provided on the website.

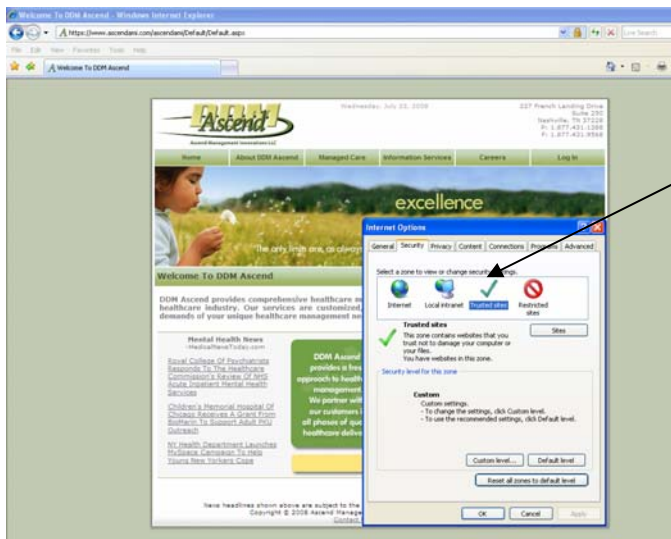
Trusted Site

Submission through the Web Based System

- Enter complete Level I screening information on the form.

*Note: Submission of incomplete information can cause delays in processing your PASRR request.

- Once you have completed the Level I form, press "submit" located at the bottom of the page.

Saving review information for up to 24 hours

With this option, you have the ability to save a review for up to 24 hours to retrieve relevant information.

- Press "save" located at the bottom of the screen.

*Note: In order to save, the patient demographic section must be completed.

- When you are ready to continue the review, log in and locate the review on the page. Enter the information and press "submit" at the bottom of the screen.

Completion of the Level I PASRR Form

After you have submitted the Nebraska Level I PASRR form using the Web Based System, you will have the option to:

- **Print the NE Level I Form:** You can print the Level I form with the information you entered and place in the patient's chart. This improves interagency communication between staff. You must enter a receiving facility before you can print the Level I form.
- **Check the Status:** You can check the status of the PASRR request 24 hours a day. You will only be able to see the PASRR requests you have submitted.
 - Go to www.PASRR.com and go to the Nebraska Web Based System.
 - Log in by clicking the icon labeled "log in".
 - Enter your user name and password.
 - Check PASRR Activity on all Level I forms which you have submitted to Ascend for up to a 2 week period.
- **Print PASRR determination letters:** Determination letters may be printed directly from the PASRR Activity Screen.
 - Go to www.PASRR.com and go to the Nebraska Web Based System.
 - Log in by clicking the icon labeled "log in".
 - Enter your user name and password.
 - PASRR Activity on all Level I forms which you have submitted to Ascend is available for up to a 2 week period.
 - Enter a receiving facility if one wasn't entered upon submission of the Level I to Ascend.
